

## Extended essay - Reflections on planning and progress form

Candidate: This form is to be completed by the candidate during the course and completion of their EE. This document records reflections on your planning and progress, and the nature of your discussions with your supervisor. You must undertake three formal reflection sessions with your supervisor: The first formal reflection session should focus on your initial ideas and how you plan to undertake your research; the interim reflection session is once a significant amount of your research has been completed, and the final session will be in the form of a viva voce once you have completed and handed in your EE. This document acts as a record in supporting the authenticity of your work. The three reflections combined must amount to no more than 500 words.

The completion of this form is a mandatory requirement of the EE for first assessment May 2018. It must be submitted together with the completed EE for assessment under Criterion E.

**Supervisor:** You must have three reflection sessions with each candidate, one early on in the process, an interim meeting and then the final viva voce. Other check-in sessions are permitted but do not need to be recorded on this sheet. After each reflection session candidates must record their reflections and as the supervisor you must sign and date this form.

### First reflection session

Candidate comments:

During my first reflection session I changed from looking at mainly novels such as Lost in Translation, Infidel and What Lang uage do I dream In, to deciding on focusing on four poems: I am Joaquin by Rodolfo Gonzalez, Home by Warsan Shire, Wh at They Took With Them by Jenifer Toksvig, and My Grandmother Washes Her Feet in the Sink of the Bathroom at Sears by Mohja Kahf. I made this choice because the poems have very strong imagery and focus primarily on dealing with identity the roughout the immigration experience from four different points of view from diverse cultures.

We also discussed my inital EE question which was too broad, therefore I changed it to a more narrow question which focus es on the immigration experience described in these four poems and how it has shaped the author's identity. My essay, we decided, will be a Category 1 Extended Essay. I chose to focus on the immigration experience in these poems and how it shapes identity because it is a topic that has become very controversial and that many people are facing today, but the immigrants actually going through the experience rarely get to voice and express their own experiences. I chose the topic because I think that immigration has a huge impact on identity, whether someone is looking for asylum or not, and this is often tied to language as well as culture. These topics are ones that I am fascinated by, especially how they are interconnected which is why I chose to explore them more thoroughly in my extended essay.

### Interim reflection

Candidate comments:

During my second reflection we discussed the potential change of my research question. Most likely the question will change from it's original: How effectively in their work do contemporary poets from different cultures convey the adjustment of perso nal identity caused by the experience of migration? to How do contemporary poets, Rodolfo Gonzales, Warsan Shire and Je nnifer Toksvig depict the personal struggle for survival of migrants and refugees? as this question seems to better fit all three poems as well as the topics I have discussed in my Extended Essay draft. We also discussed the need for a change in struc ture of the essay. Instead of discussing each poem individually and analyzing each on it's own, we agreed that the essay wo uld be more interesting and appealing if it focused on specific stylistic devices such as voice, choice of narrator, and repetition that the author chose and how these compare.

We also discussed the potential significance of the name Joaquin in Rodolfo Gonzalez's poem "I am Joaquin" and we came to the conclusion that most likely he chose it because of it's common appearance in Latin America and his attempt at trying to make his poem and his message relatable. Lastly the need for further analysis of specifically Warshire's and Toksvig's poem is necessary in order to not be to descriptive and more analytical. Toksvig's poem in fact was written with different voices/people in mind, something I didn't realize which I will now change and analyze at depth.

Candidate comments:

Over the course of writing my EE I feel that my idea of how to structure an essay, especially one on various works, has chan ged drastically for the better. Instead of analyzing each point from each seperate poem I learned to find a common aspect th at the poems shared and in that way analyze the same aspect in all of my three poems. In that way the essay was more coh erent and interesting. I also discussed with my supervisor the fact that all three of the poems that I chose are not very well kn own, in fact one isn't even officially published, and as a result at times it was hard to get a clear view of the message the poe ts were trying to get across, and analysis was often done to some extent in the dark. I think I put very much my own perspect ive on the poems and my personalized analysis, also because although I did a fair amount of research it was very rare to find much information on any of the works. This was a struggle, but also what made the work even more interesting, precisely because there wasn't much said yet.

Perhaps the most challenging aspect of the process was structuring the essay and arguing coherent points, making smaller conclusions and then delving more deeply into the portrayals in these poems to develop a really meaningful conclusion. changed the structure between drafts and found it hard to find a good overall structure, and to develop an independent and deeply engaged response to all the poems in relation to the question. She shows a good ability with specific literary analysis of techniques and devices, but did have some problems in finding secondary sources, so bearly all the ideas that she developed were her own responses to these poems.
