First reflection session

Candidate comments:
My supervisor and I discussed my initial research question, "How does normalizing mental illnesses act as a placebo effect among the masses?". With more people expressing their illnesses on social media, I am interested in researching whether it causes more people to diagnose themselves, even when they do not have a mental illness. However, I could not find any statistics providing evidence, so I had to change it. Alternatively, came up with the question "To what extent does visual media affect the prevalence of mental illness in society?" I plan to research whether media on mental illness increases the rate of the mental illness it features after its release. For evidence, I plan to discuss how psychological concepts like copycat behavior can influence the rates of mental illness by finding data on the rate change of a mental illness before and after the release of a certain form of media, evaluating whether it was influenced by the release of that media. My only concern is that I may not find much direct empirical evidence on this subject, but there are a lot of studies on topics like copycat behavior that I can apply to support my stance.

Interim reflection

I realized my question was too broad and decided to narrow my scope of research. After discussing with my supervisor, I changed my question to, "To what extent does the "copycat effect" explain similar suicide occurrences subsequent to mass
media coverage on non-fictional and fictional suicides?". I modified my question after finding several scientific studies debating the validity of the "copycat effect" because there is no formal theory listed in any psychology textbooks. I found psychology textbooks to research widely accepted theories that could potentially substantiate the copycat effect. I analyzed the scientific studies I found, sorting them out as either primary sources or narrative reviews and either fiction or nonfiction. Accordingly, I divided my essay into three categories: the foundation of the copycat effect and its significance in non-fictional and fictional media. One difficulty I discussed with my supervisor was incorporating relevant news into my essay, which I
wanted to include but am finding difficult to include since such stories are not thoroughly investigated.

Initially, I had trouble coming to a conclusive answer about my findings due to several confounding results. However, this issue was quickly solved after I researched further on different methods of gathering data, ultimately using meta-analysis to confirm my findings. After quantifying my data, discovering patterns among the several cases I studied became much easier and gave me a holistic perspective on the several ways the "copycat effect" pervades in non-fictional and fictional media. Overall, the topic I chose highly interested me, which made writing my EE very engaging. After learning about the foundation of the copycat effect, the results I found made a lot of sense, especially regarding the high prevalence of copycat suicides imitating celebrities. Given this research, I plan to continuing studying how stricter media regulations can be implemented to curb these effects from occurring.
